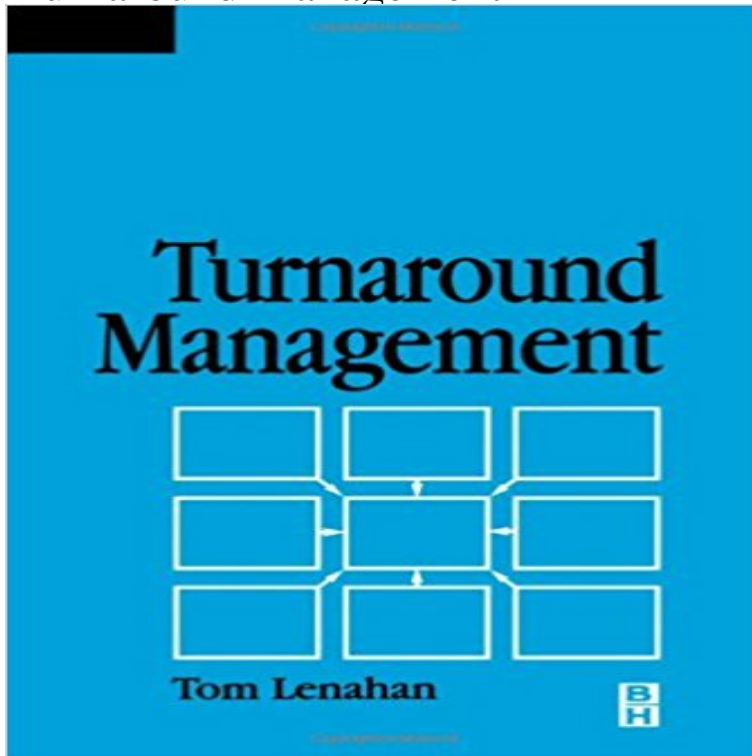


# Turnaround Management
