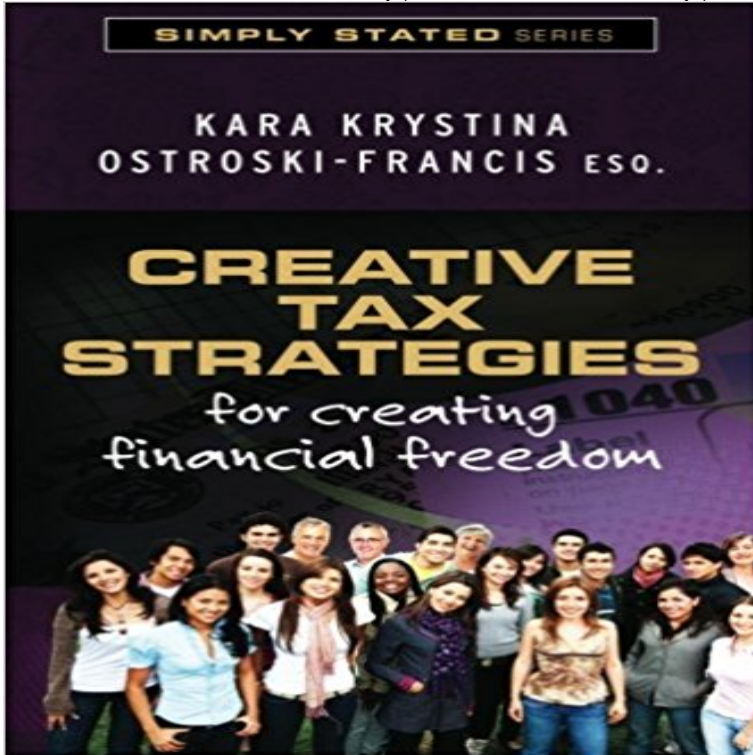


## Creative Tax Strategies for Creating Financial Freedom (Volume 2)
