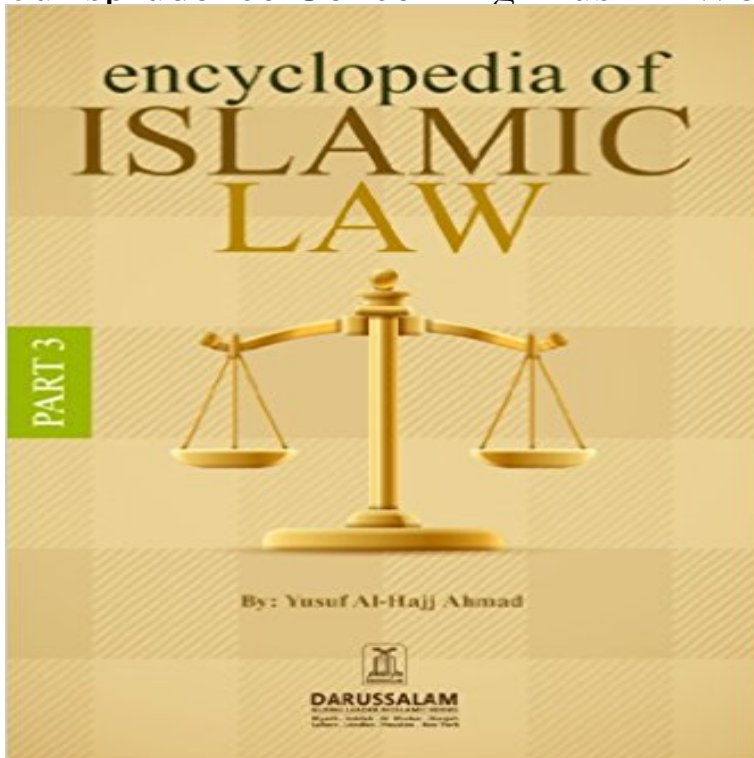


Encyclopaedia of Islamic Law - Vol III (Encyclopedia of Islamic Jurisprudence Concerning Muslim Women Book 3)
