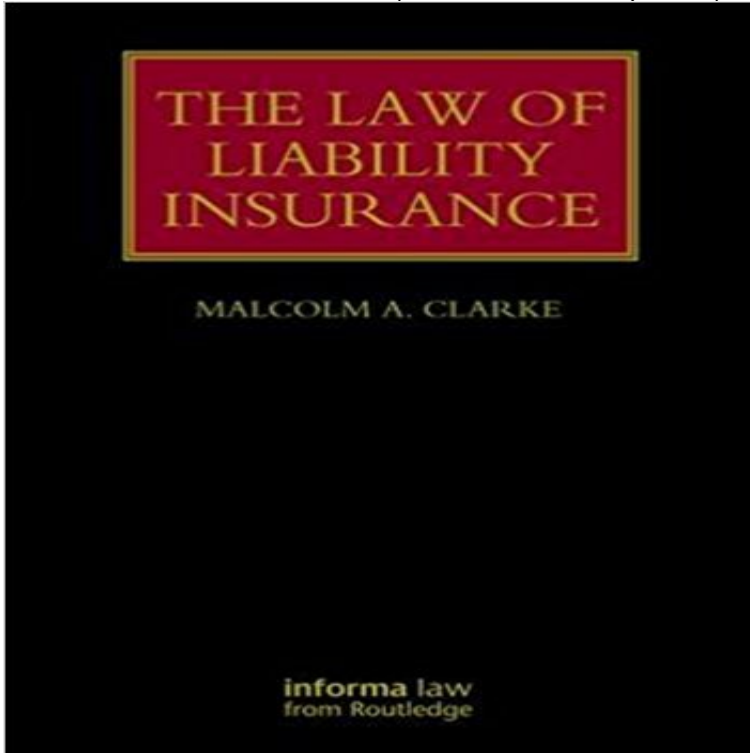


# The Law of Liability Insurance (Lloyds Insurance Law Library)
