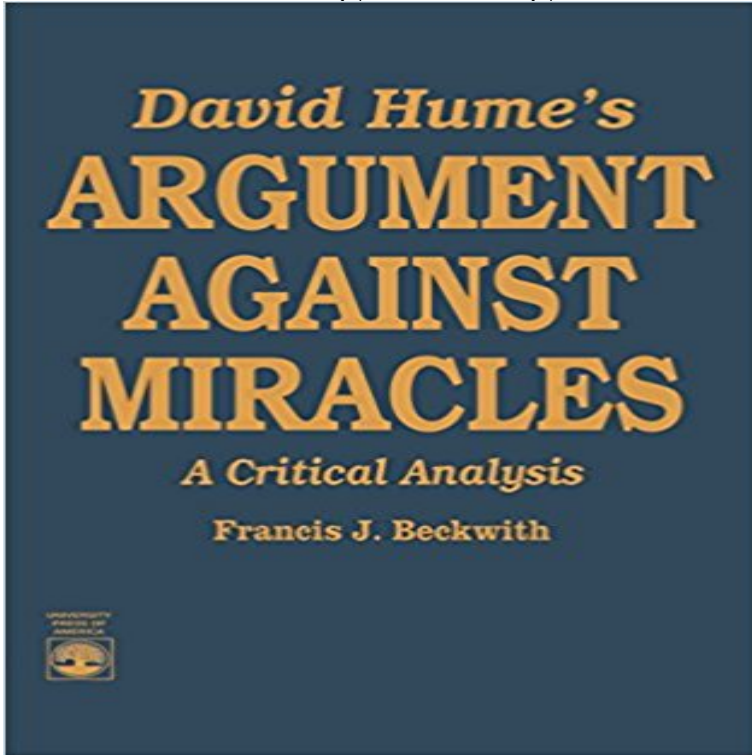


## David Humes Argument Against Miracles
