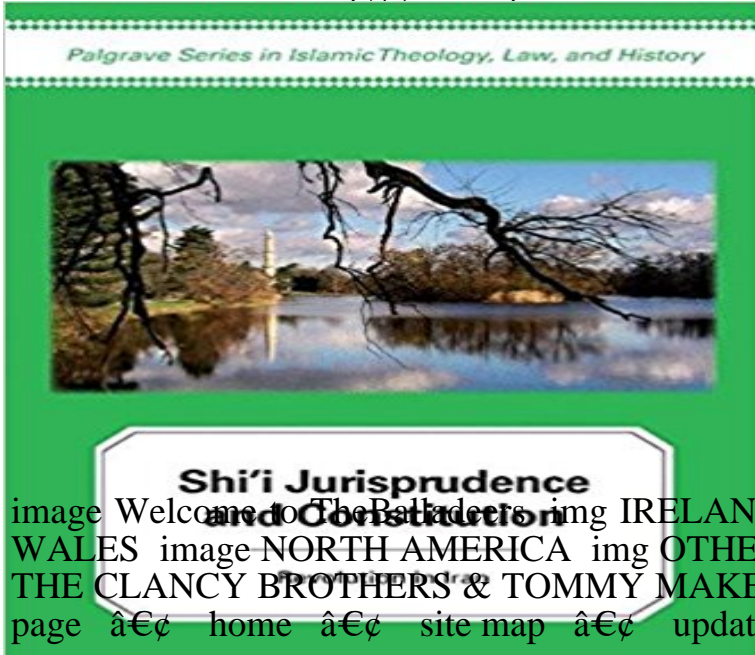


# Shii Jurisprudence and Constitution: Revolution in Iran (Palgrave Series in Islamic Theology, Law)
