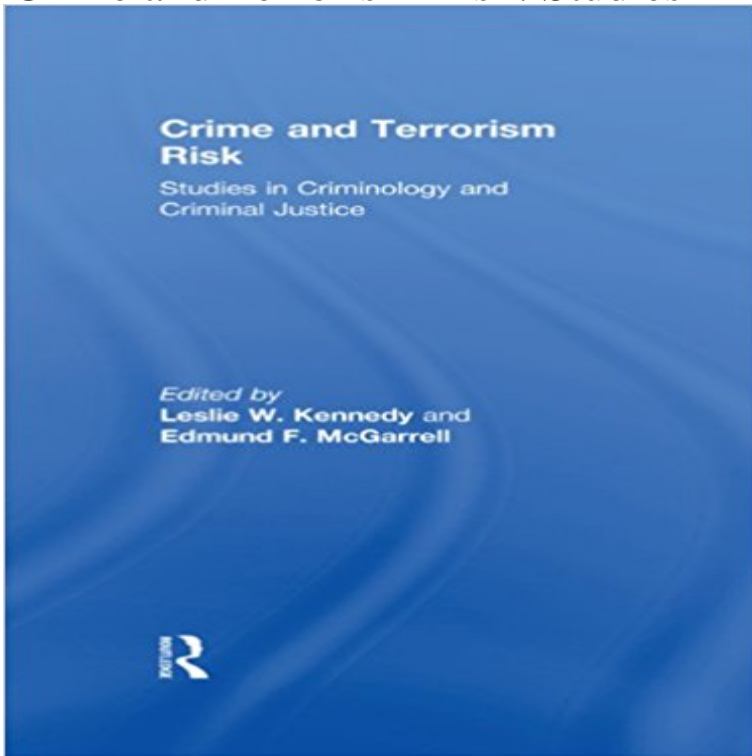


Crime and Terrorism Risk: Studies in Criminology and Criminal Justice
