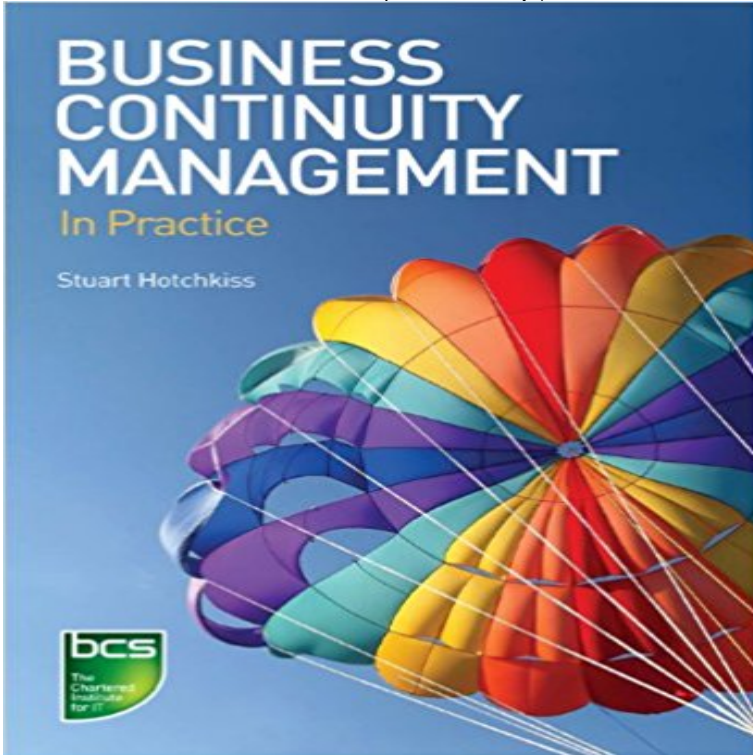


Business Continuity Management: In Practice
