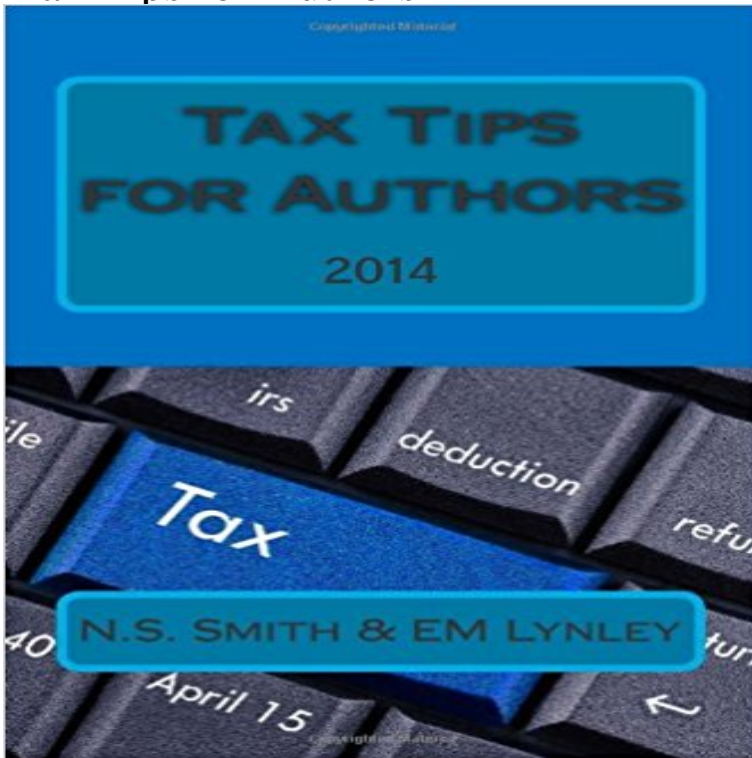


Tax Tips for Authors
