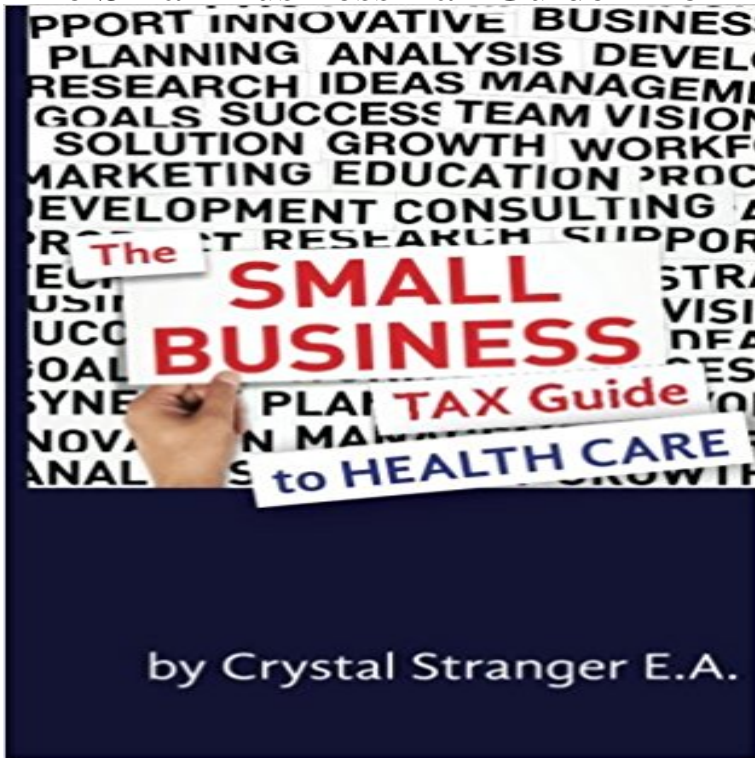


The Small Business Tax Guide - To Health Care
