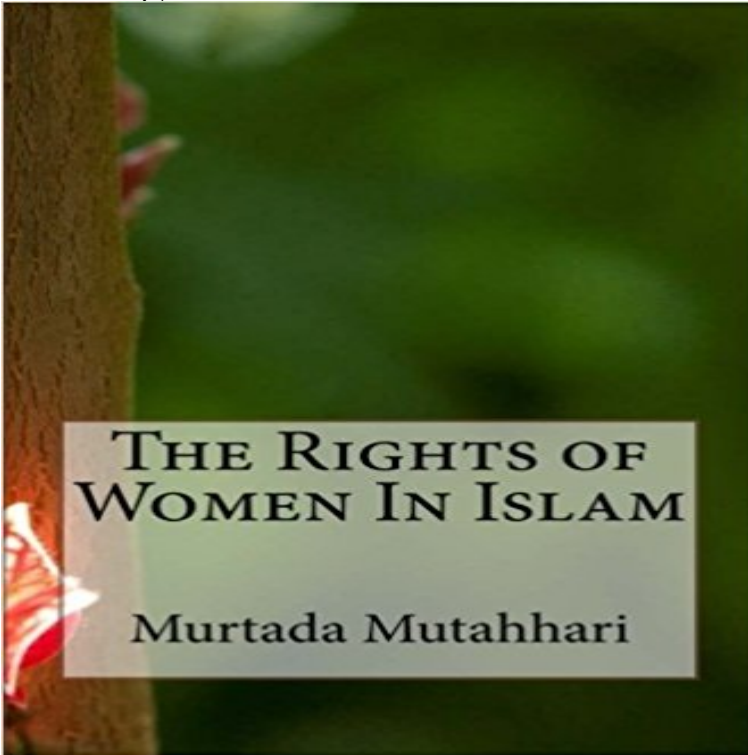


The Rights of Women In Islam
