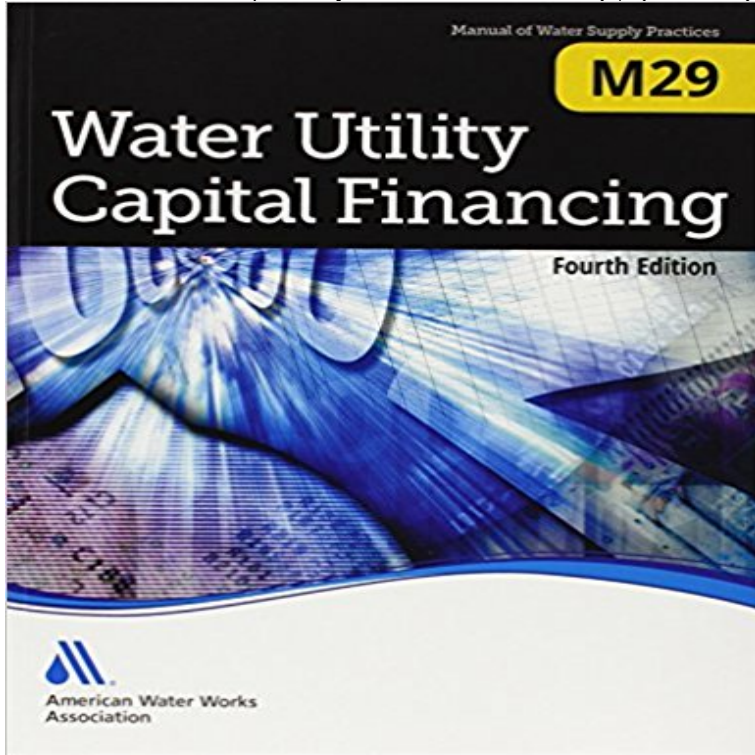


Water Utility Capital Financing (M29): AWWA Manual of Practice
