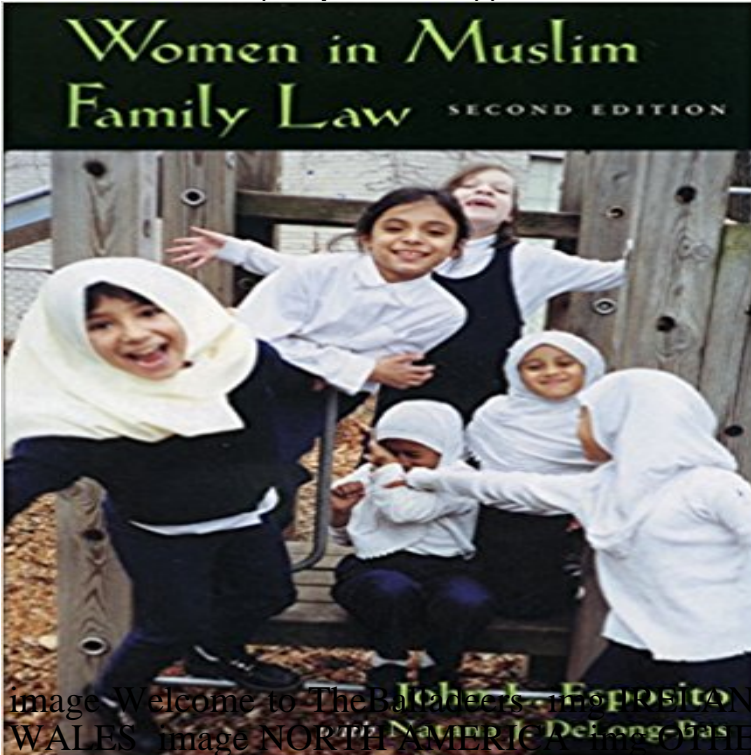


Women in Muslim Family Law, 2nd Edition (Contemporary Issues in the Middle East (Paperback))
