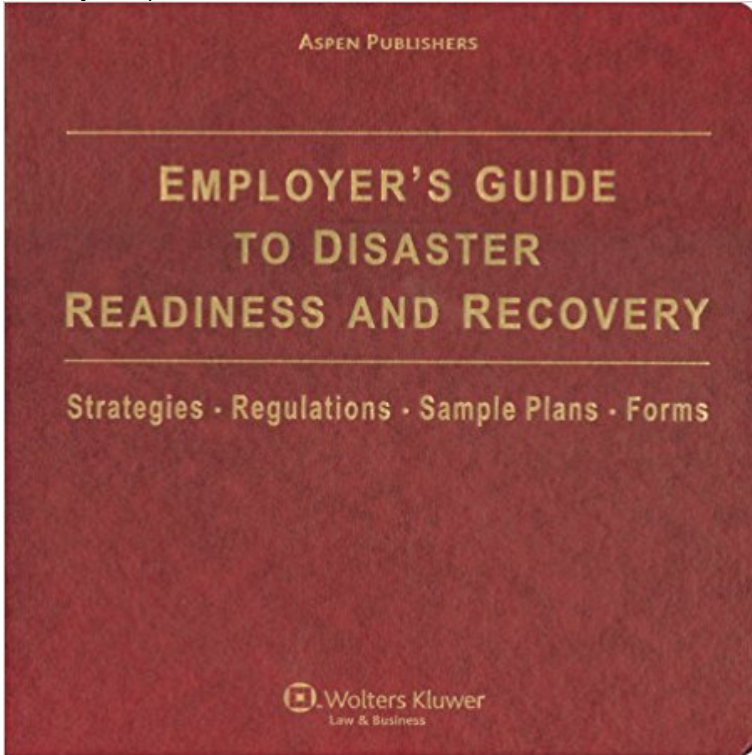


# Employers Guide to Disaster Readiness and Recovery



Disasters are a function of natural forces, accidents, or intentional hostile acts. The Employers Guide to Disaster Readiness and Recovery is designed as a business continuity how-to book; it provides step-by-step processes and tools that take a business through preparing for a disaster to implementing a business recovery. It helps an employer prepare its organization - leaders, managers, and employees - for the challenges of a catastrophic event. The Guide addresses four major areas of concern for a business: protecting people, protecting business assets, business continuity, and legal compliance. It provides a comprehensive disaster planning guide in a single, easy-to-use volume, including 48 checklists, 6 sample plans, 11 tip sheets, 10 action lists, and 2 worksheets. and restore business assets;  
Chapter 6: addresses the human aspects of disaster recovery, including employee communications, compliance with state disaster leave laws, and federal discrimination, benefits, and wage and hour laws.
