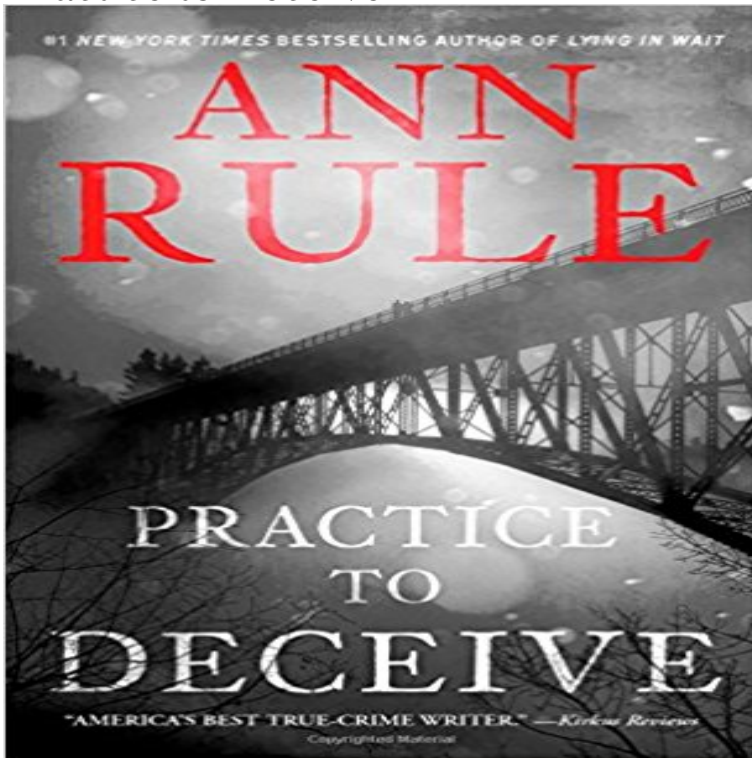


Practice to Deceive
