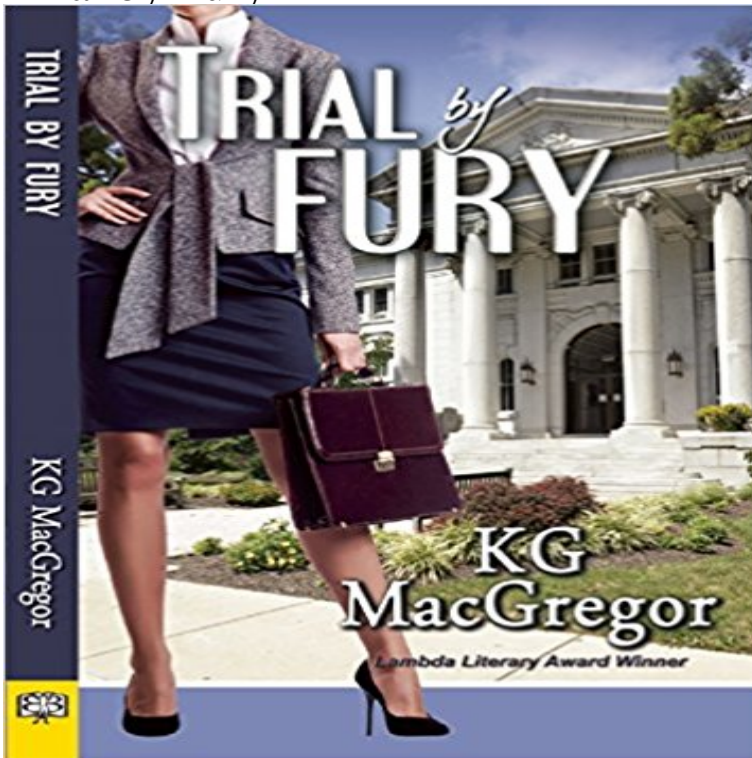


Trial by Fury
