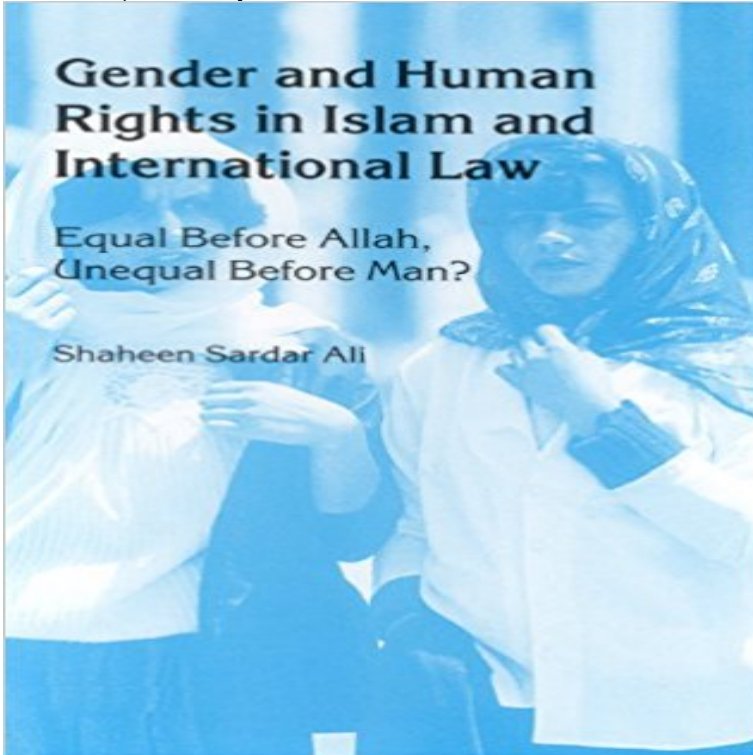


Gender and Human Rights in Islam and International Law:Equal Before Allah, Unequal Before Man?



This important study offers a conceptual analysis of gender and human rights under Islamic law, state law and international law, and extends this analysis to a specific examination of the nature of womens rights in the Islamic tradition. It explores the disparity between the theoretical perspective on womens rights and its applications to Muslim jurisdictions, determined by elements of cultural practices, socio-economic realities and political expediences, and uses the example of Pakistan to demonstrate the divergence between the theory and practice of Islamic law in these jurisdictions. It discusses the concept of an emerging operative Islamic law, which includes principles of Islamic law, secular codes and popular custom and usage.
