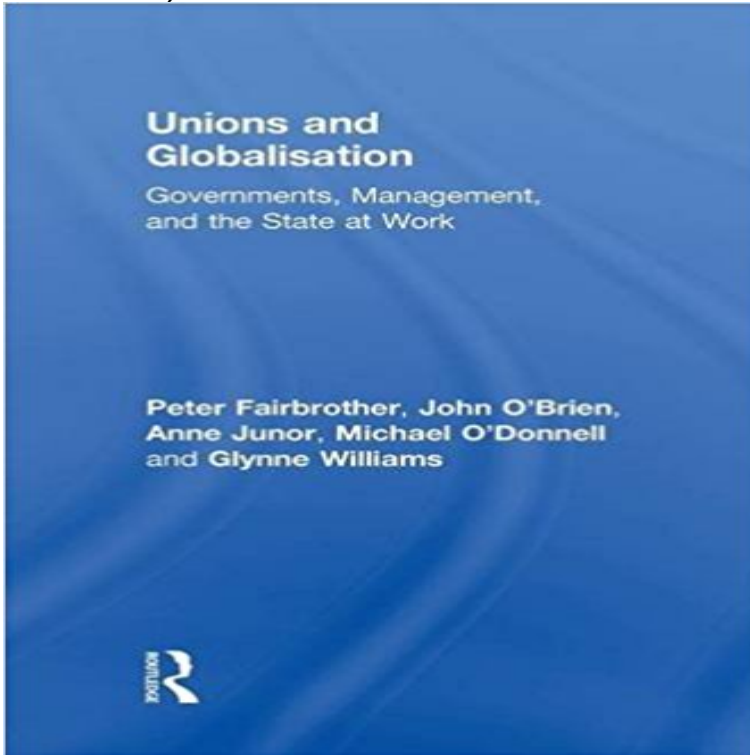


Unions and Globalisation: Governments, Management, and the State at Work (Routledge Studies in Employment and Work Relations in Context)
