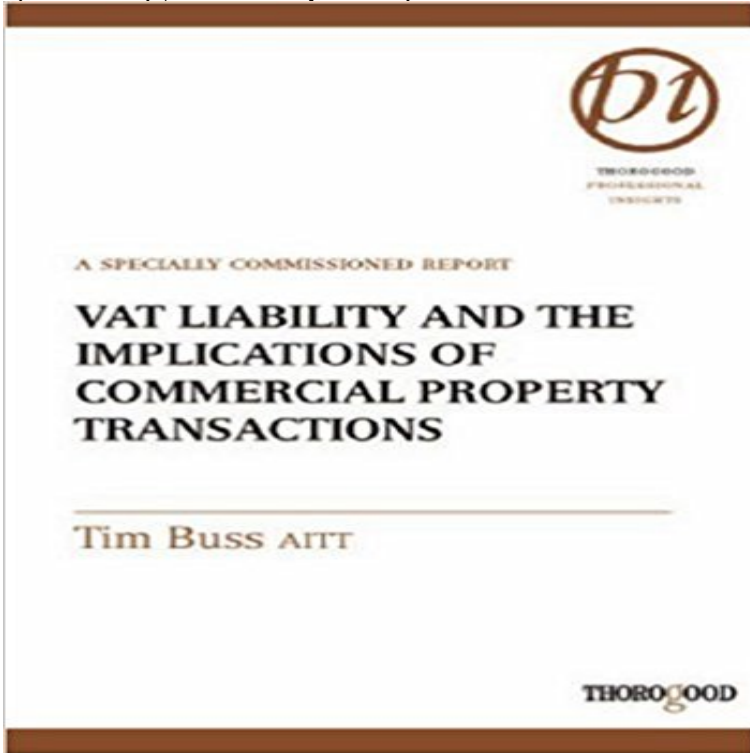


VAT Liability and the Implications of Commercial Property Transactions (Thorogood Reports)
