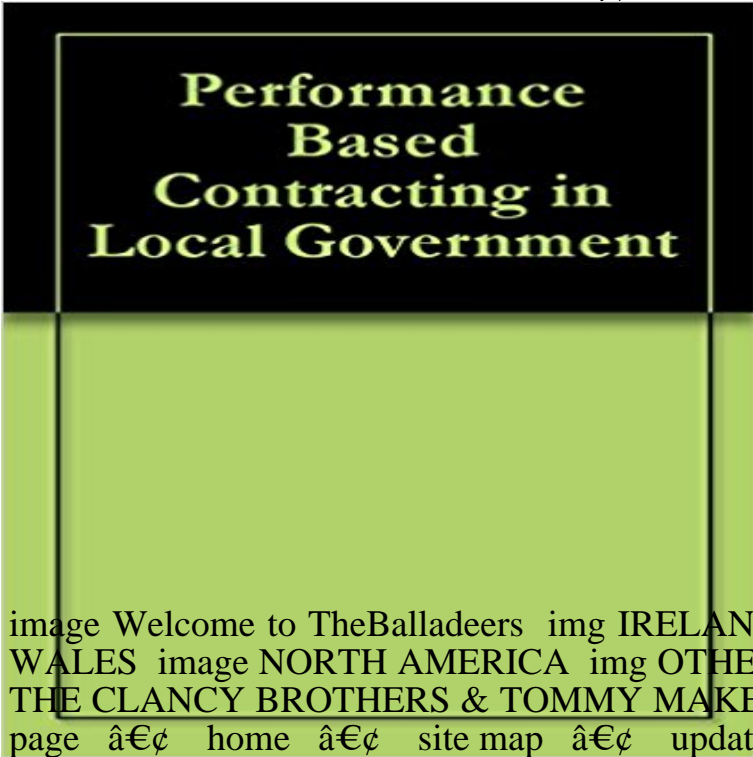


# Performance Based Contracting in Local Government
