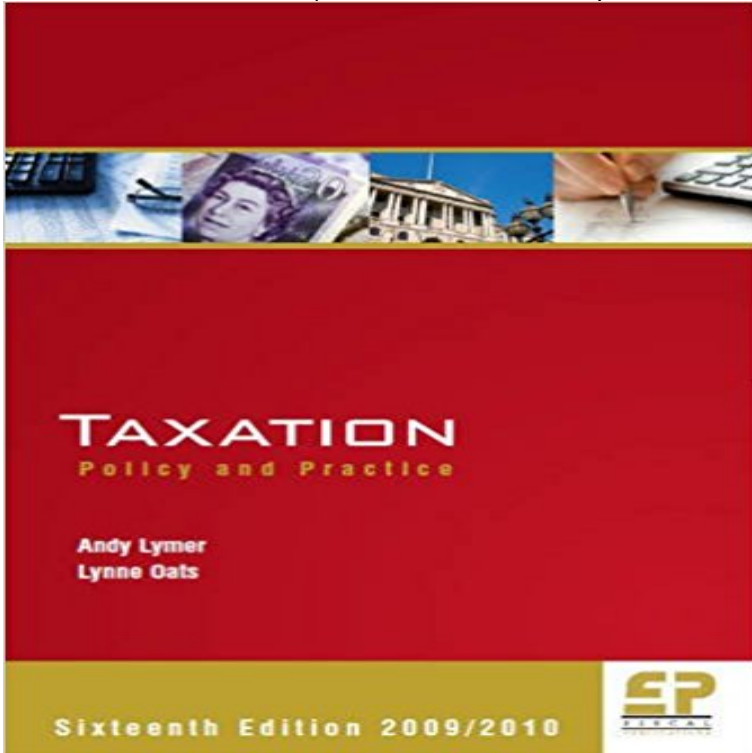


Taxation: Policy and Practice (16th edition 2009/10)
