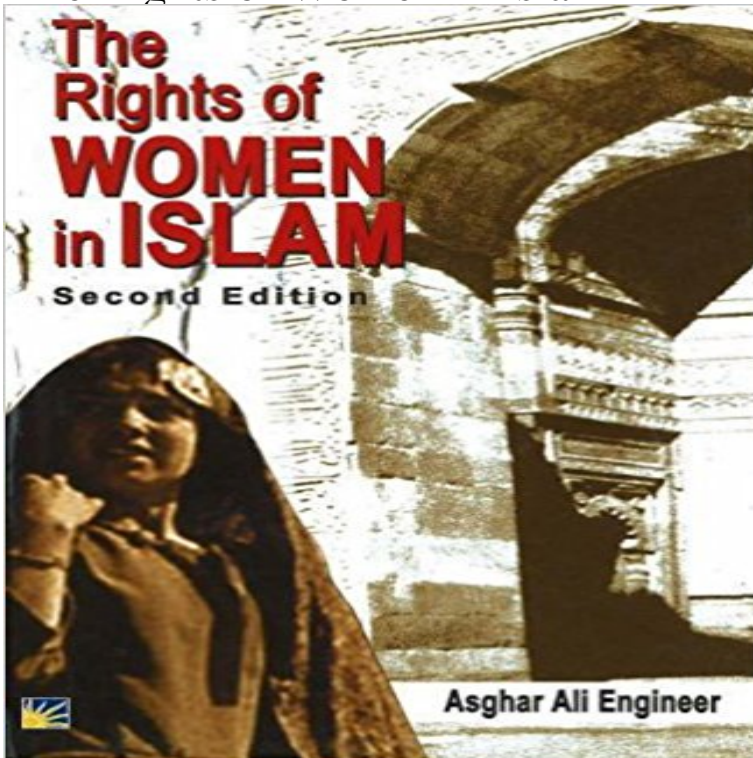


The Rights of Women in Islam
