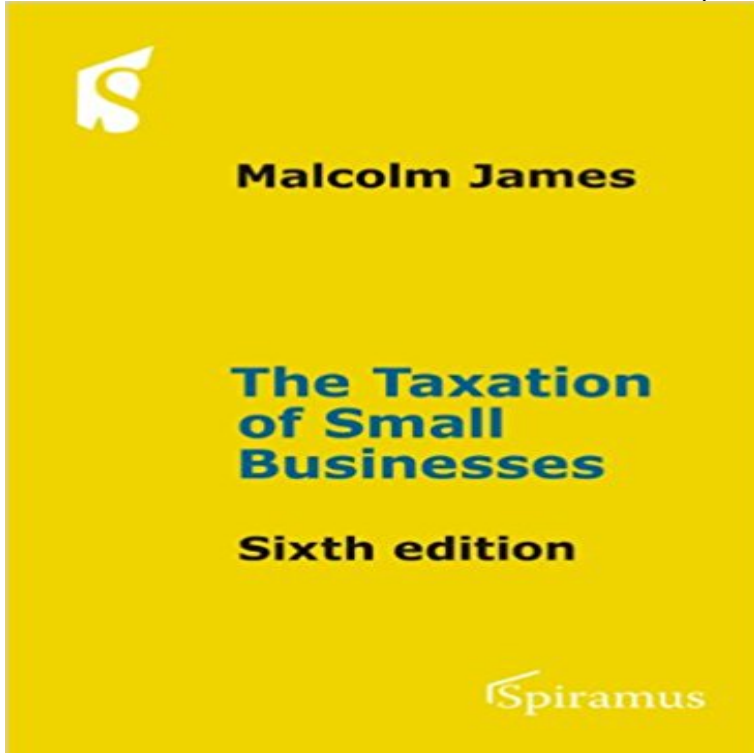


The Taxation of Small Businesses: (Sixth Edition)
