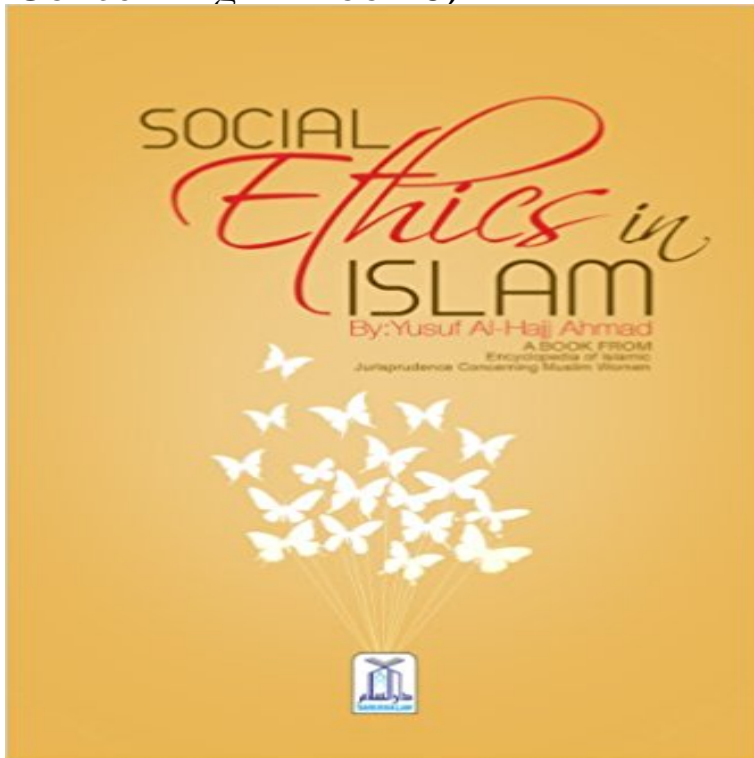


Social Ethics in Islam (Encyclopedia of Islamic Jurisprudence Concerning M Book 6)
