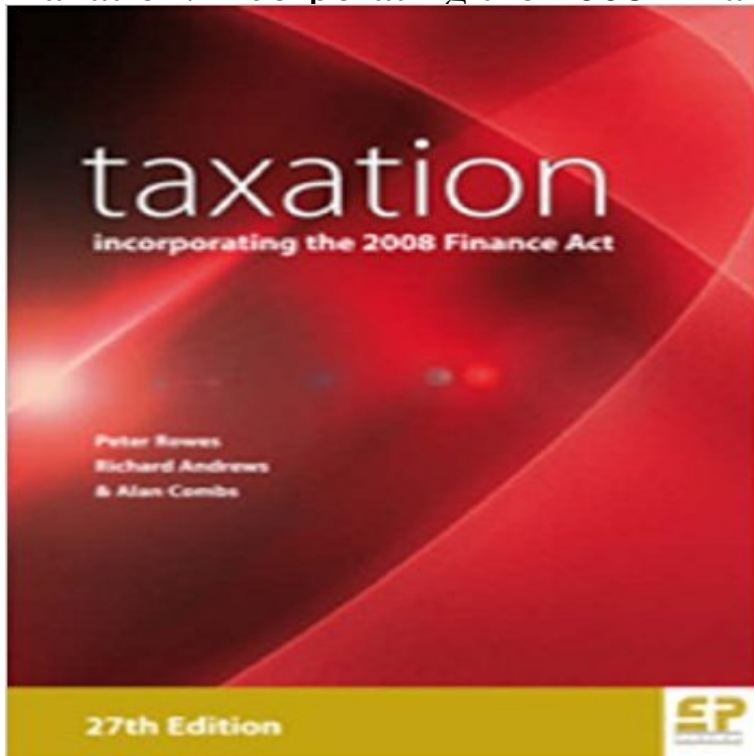


# Taxation: incorporating the 2008 Finance Act (27th edition)
