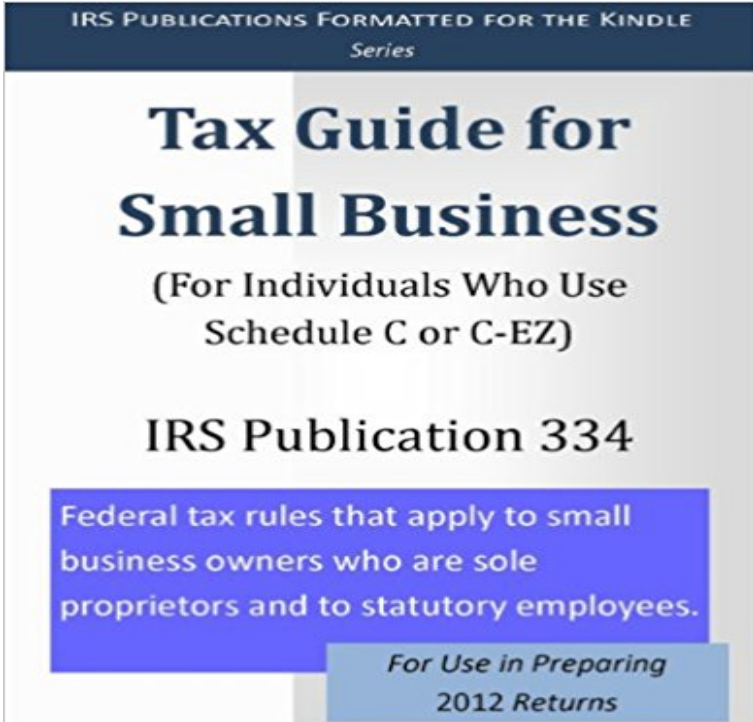


# IRS Publication 334: Tax Guide for Small Business (For 2012 Returns)
