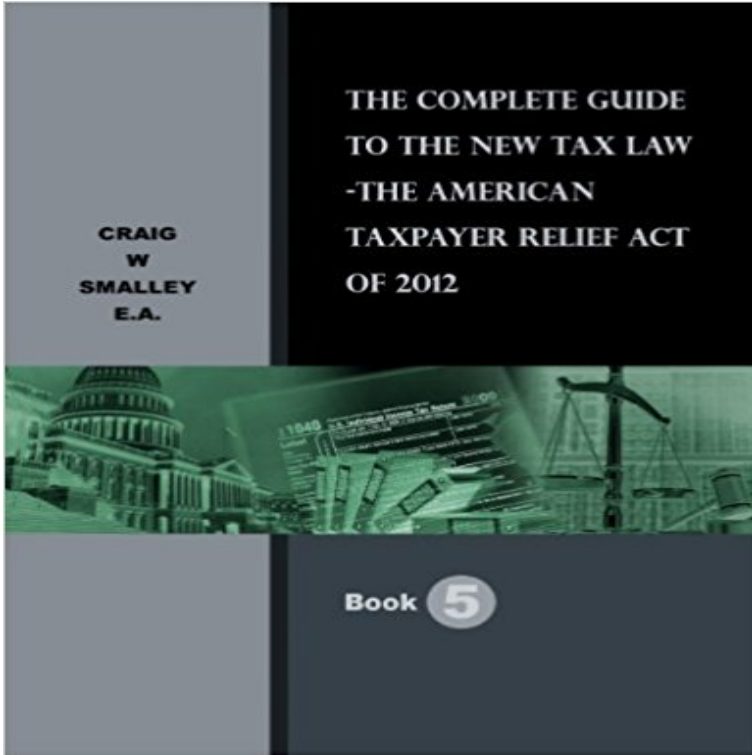


The Complete Guide to the New Tax Law - American Taxpayer Relief Act of 2012
