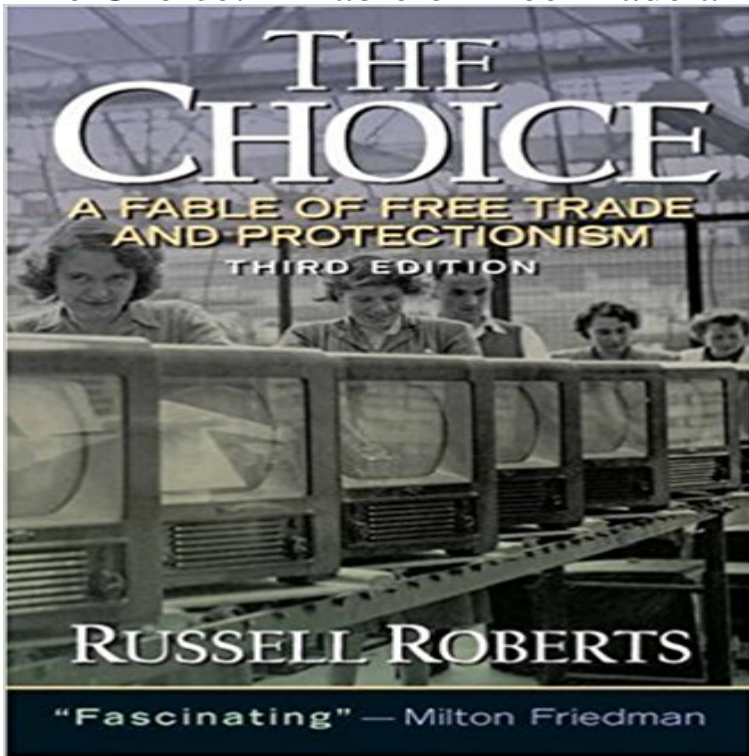


The Choice: A Fable of Free Trade and Protection (3rd Edition)
