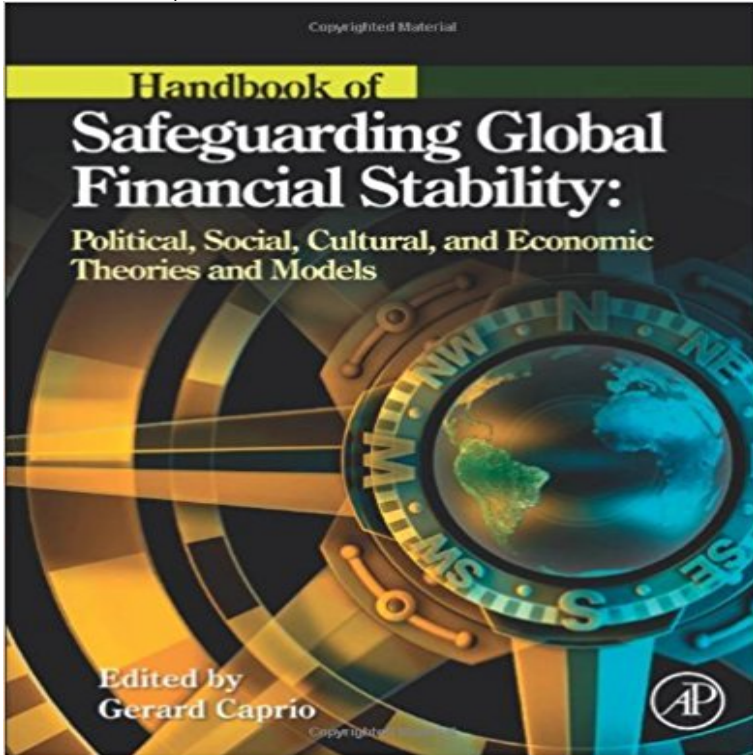


Handbook of Safeguarding Global Financial Stability: Political, Social, Cultural, and Economic Theories and Models
