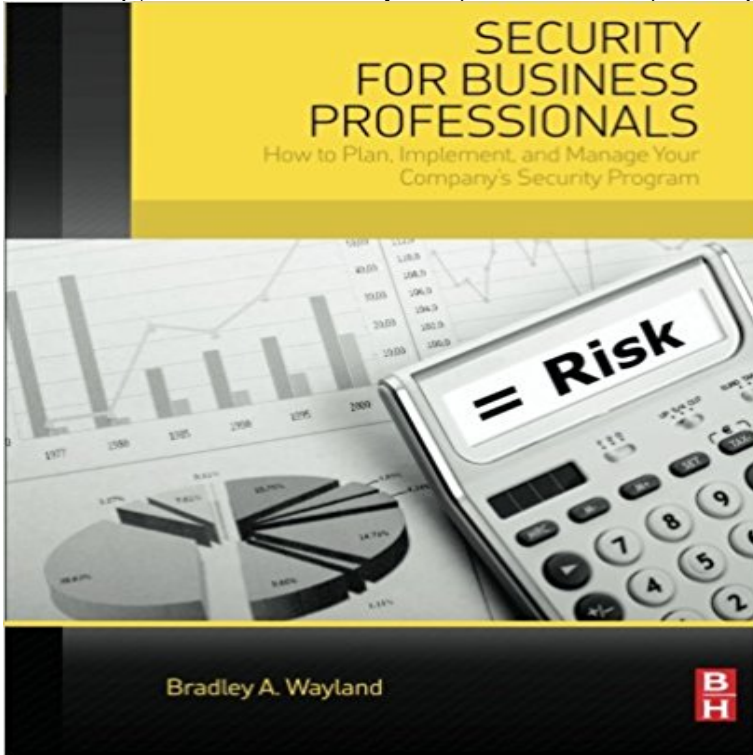


Security for Business Professionals: How to Plan, Implement, and Manage Your Company's Security Program
