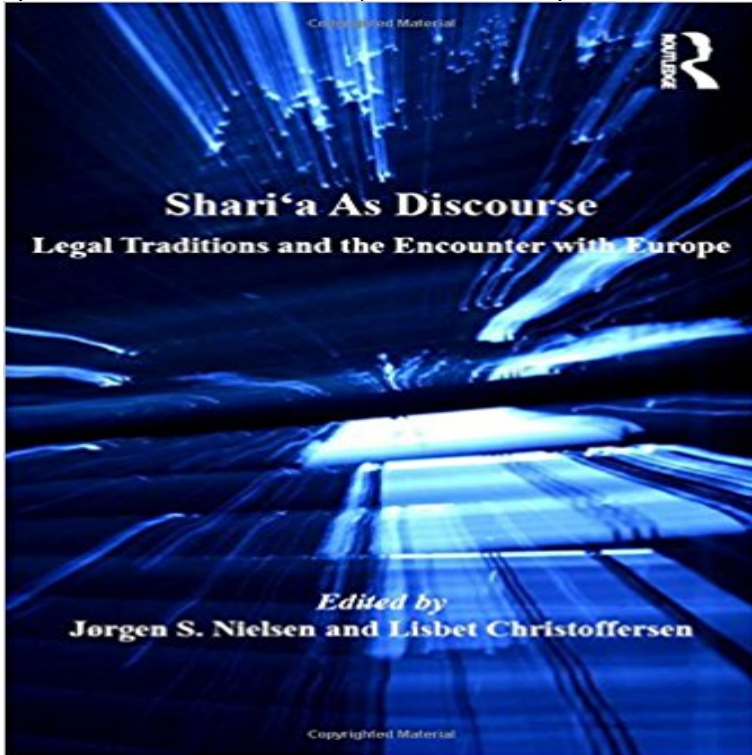


Sharia As Discourse: Legal Traditions and the Encounter with Europe (Cultural Diversity and Law)
