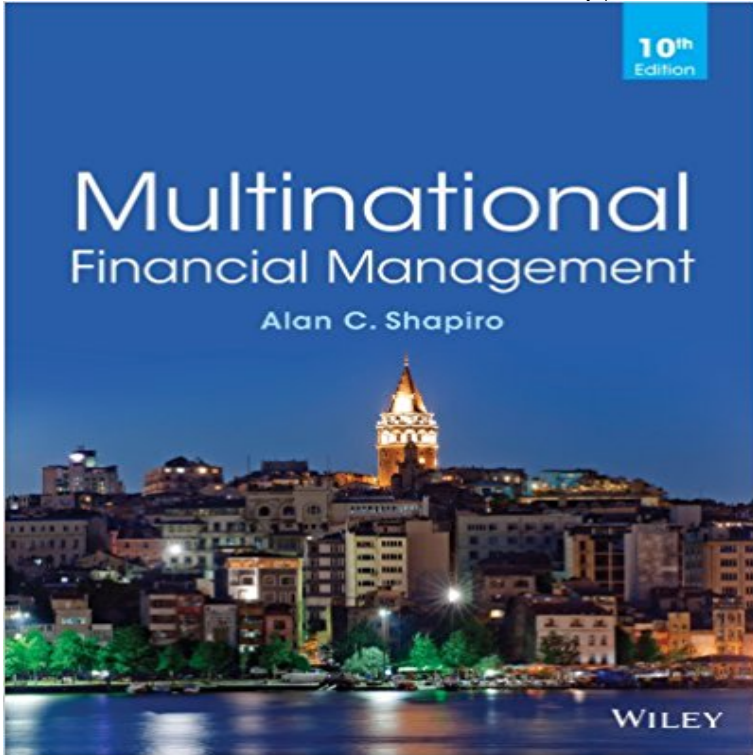


Multinational Financial Management
