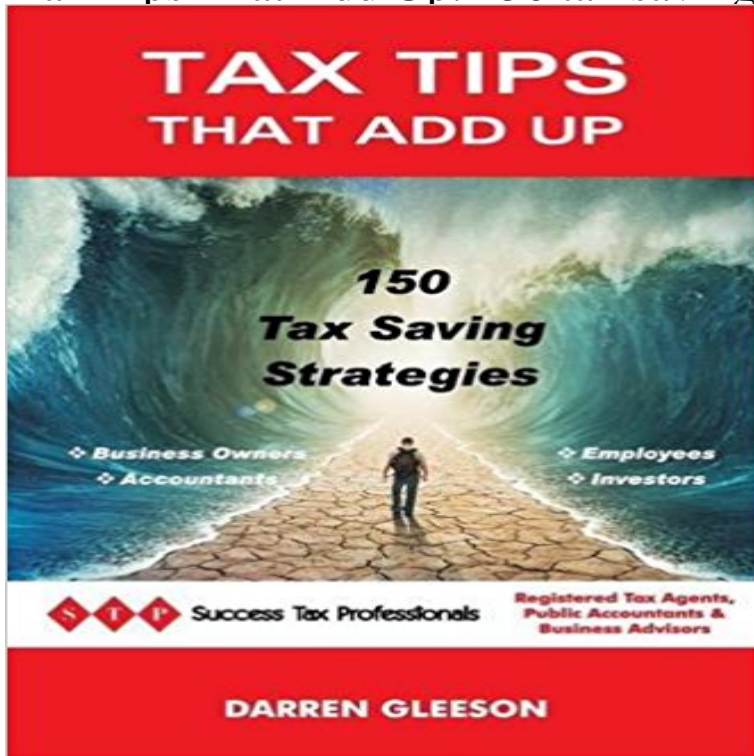


Tax Tips That Add Up: 150 tax saving strategies
