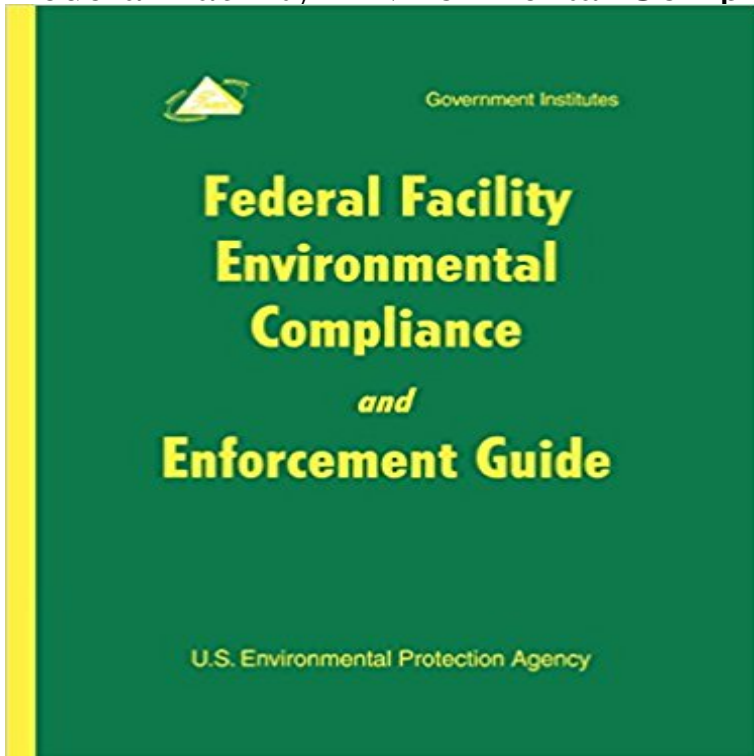


Federal Facility Environmental Compliance and Enforcement Guide
