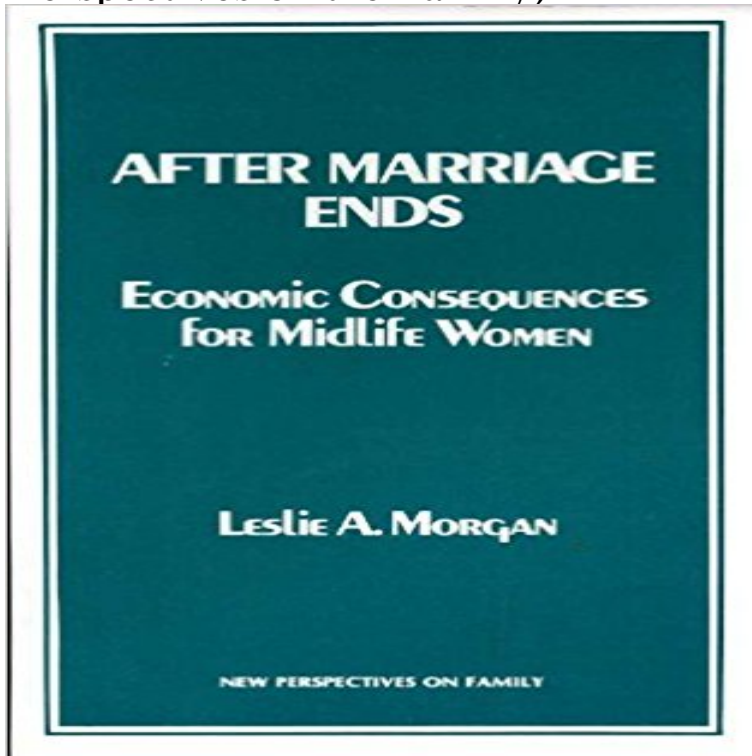


After Marriage Ends: Economic Consequences for Midlife Women (New Perspectives on the Family)
