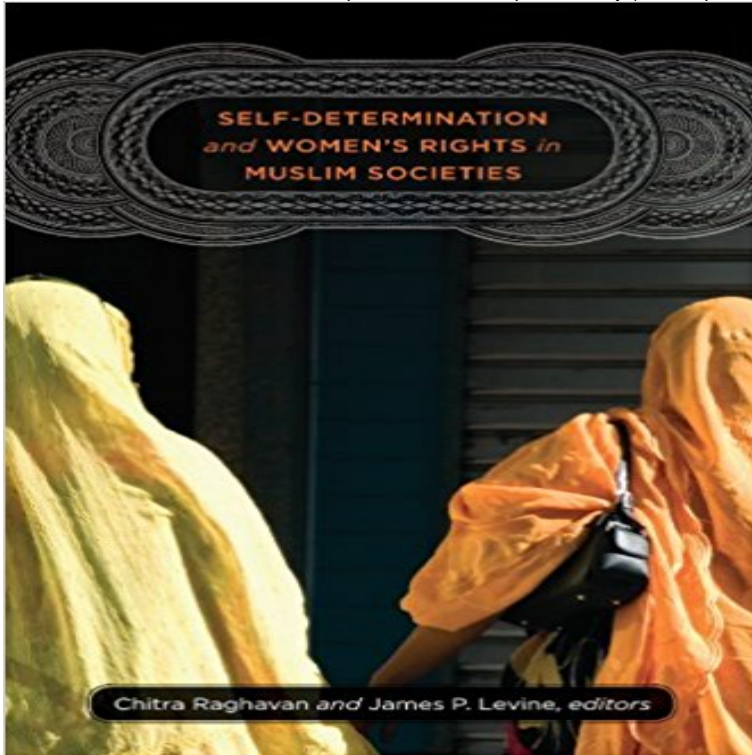


Self-Determination and Womens Rights in Muslim Societies (Brandeis Series on Gender, Culture, Religion, and Law)
