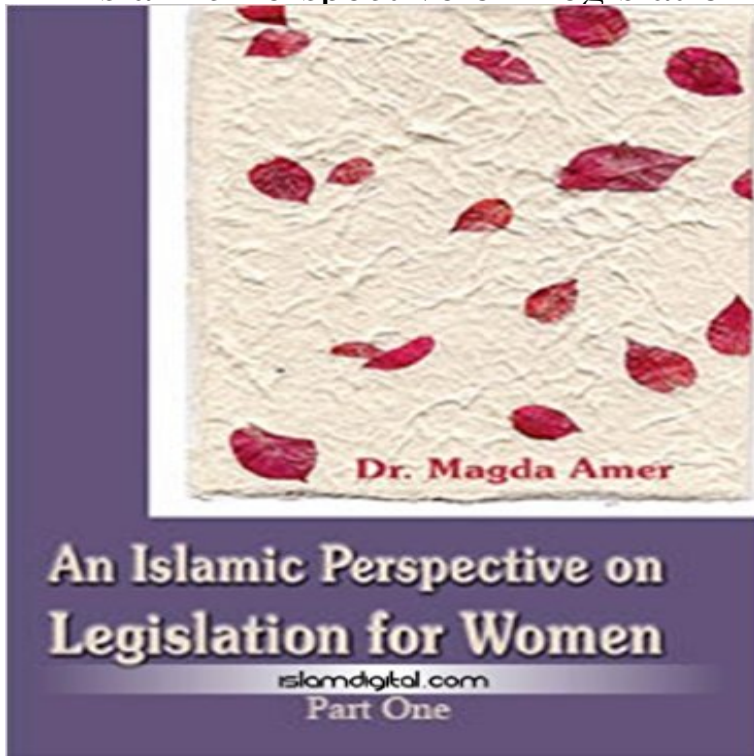


An Islamic Perspective on Legislation for Women Part I
