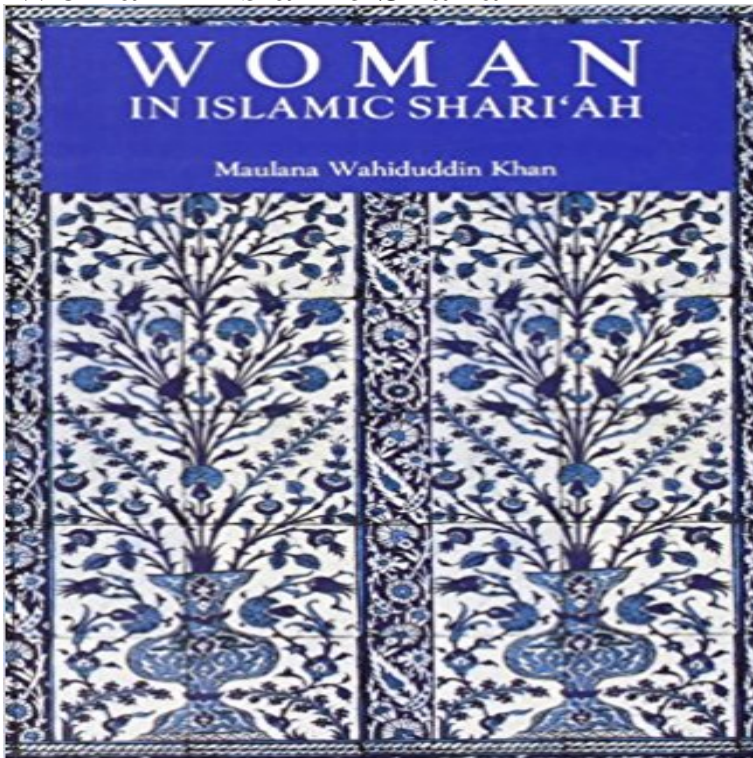


Woman in Islamic Shariah
