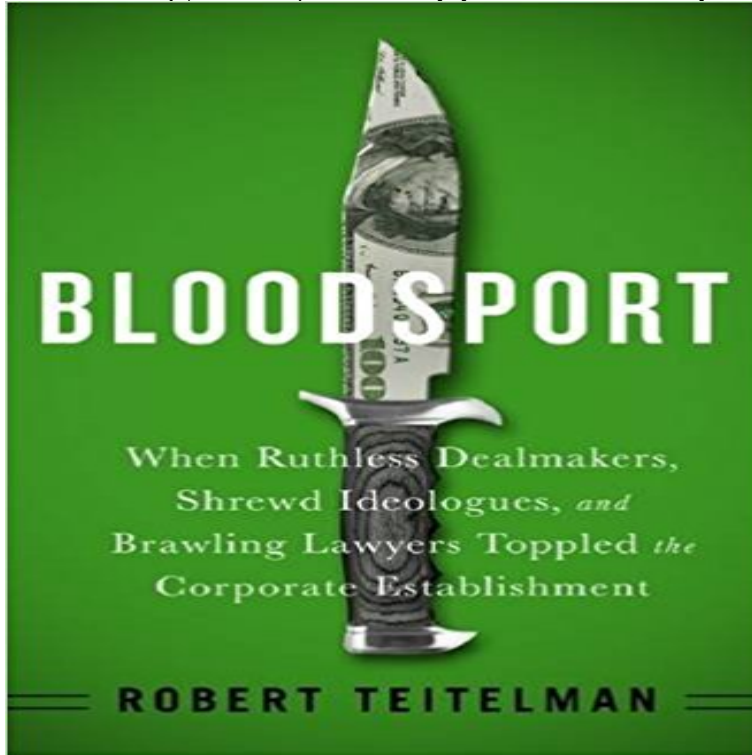

This battle of ideas became the "bloodsport" of American business. It set in motion the deal-making culture that led to the financialization of the economy and it is the backstory to ongoing debates over

competitiveness, job losses, inequality, stratospheric executive pay, and who owns America's corporations.
