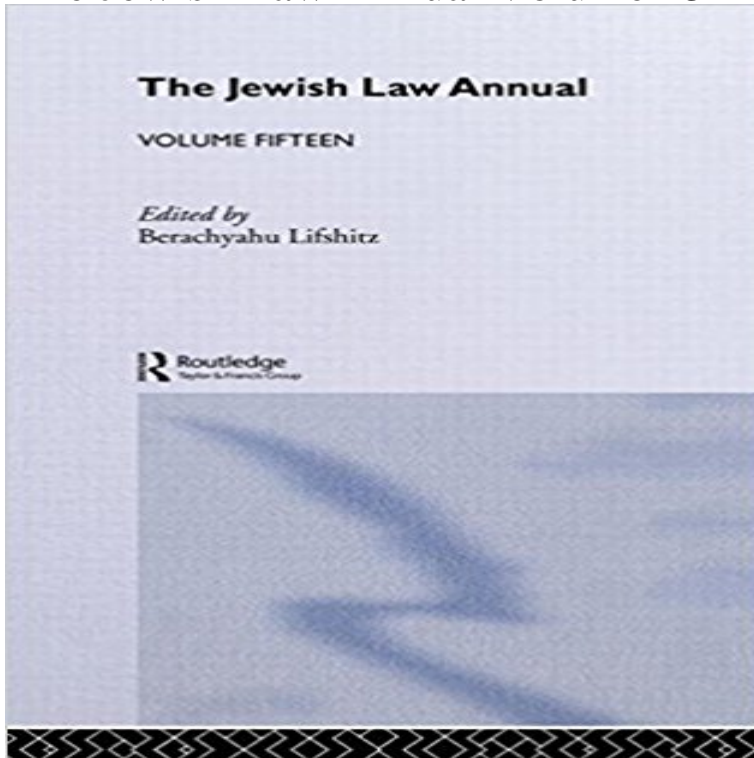


# The Jewish Law Annual Volume 15
