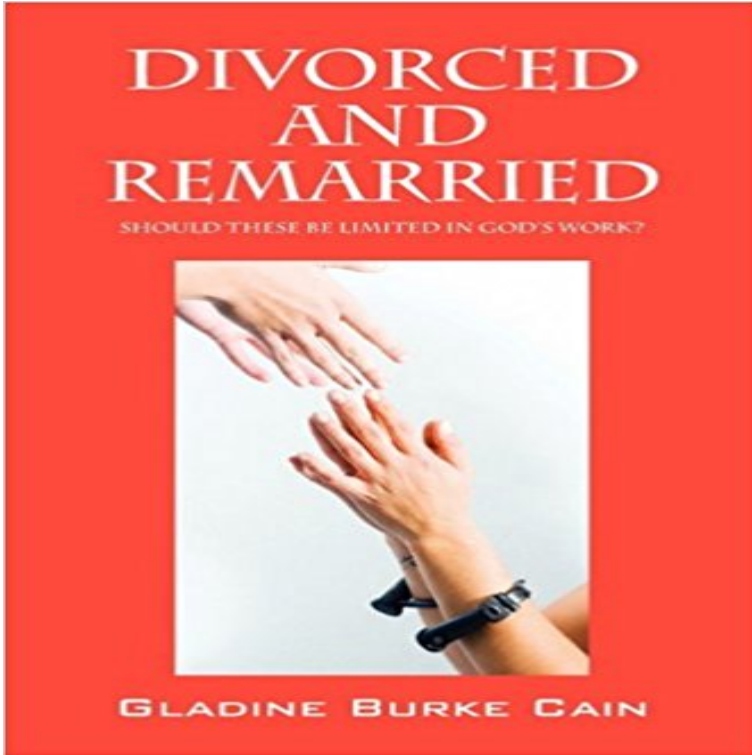


# Divorced and Remarried: Should These Be Limited in Gods Work?
