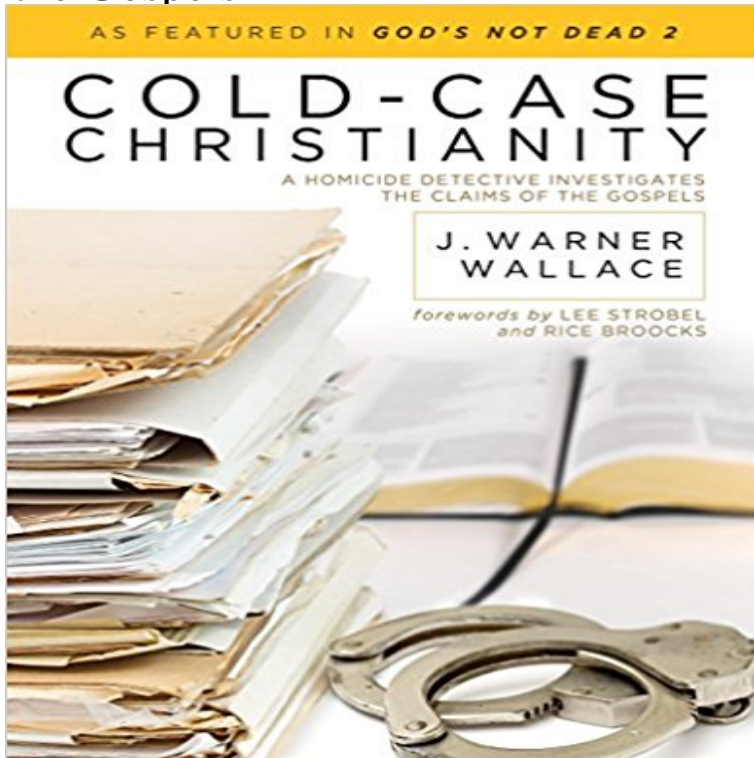


Cold-Case Christianity: A Homicide Detective Investigates the Claims of the Gospels
