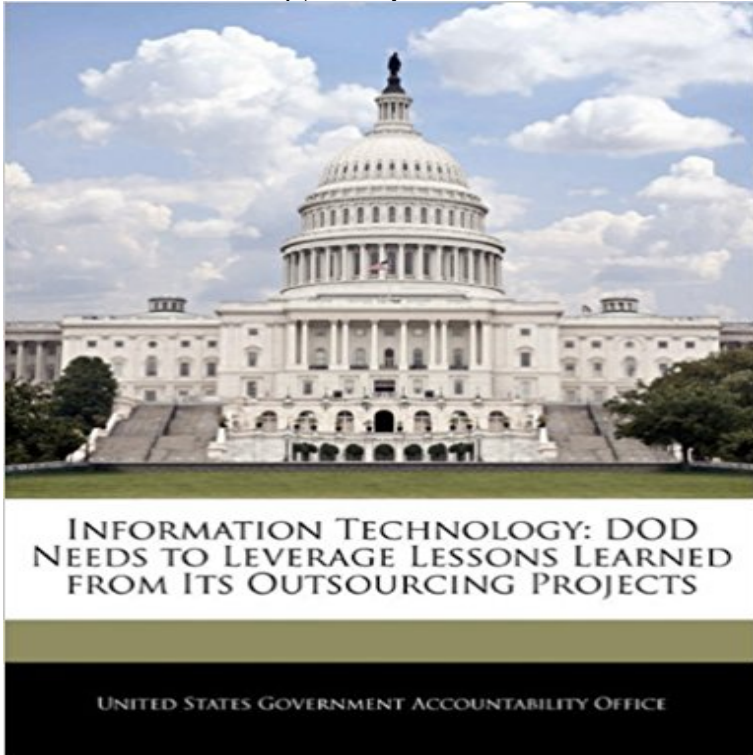


Information Technology: DOD Needs to Leverage Lessons Learned from Its Outsourcing Projects
