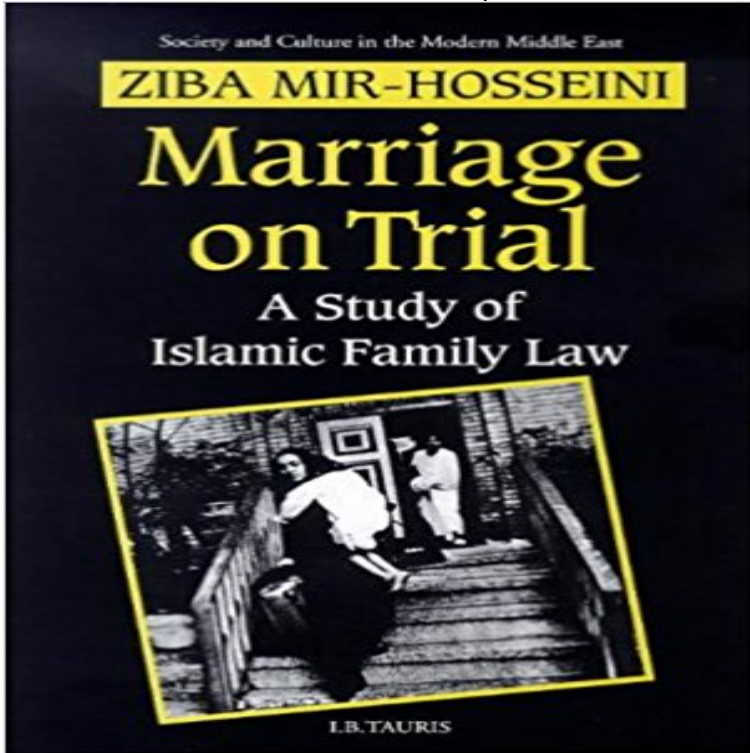


# Marriage On Trial: A Study of Islamic Family Law (Society & Culture in the Modern Middle East)
