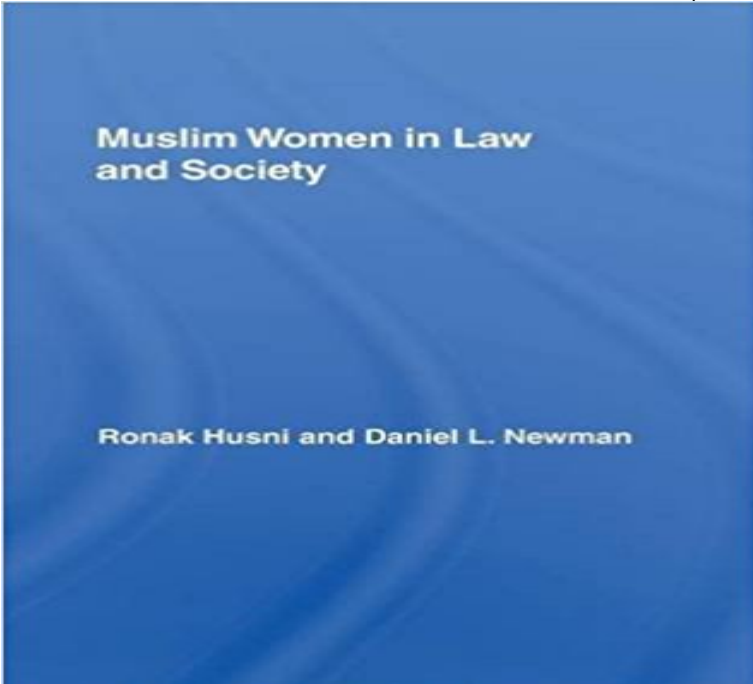


# Muslim Women in Law and Society
