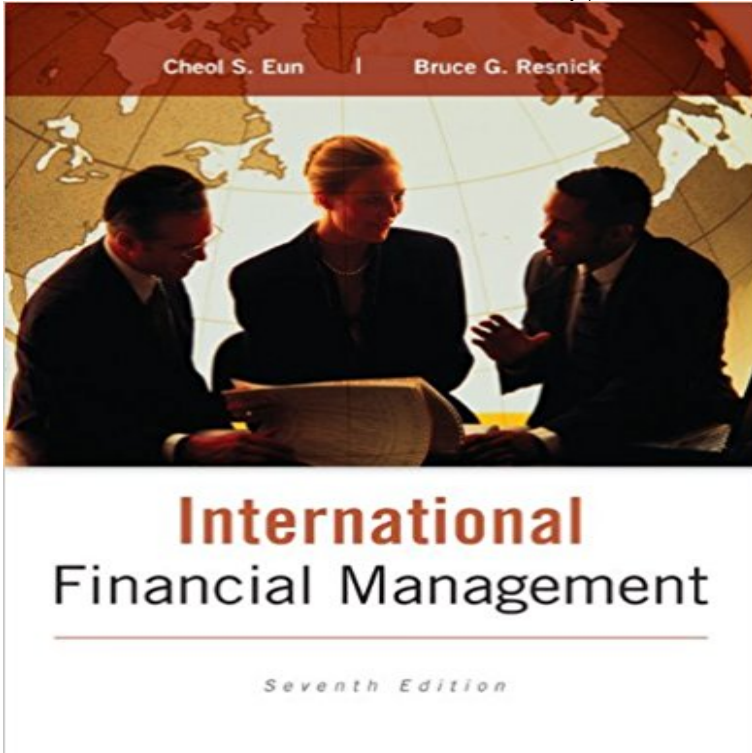


International Financial Management
