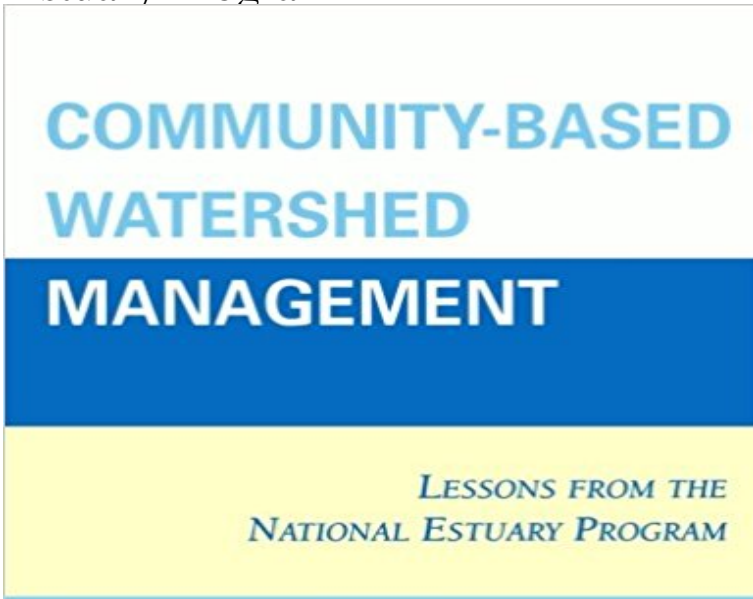


# Community-Based Watershed Management: Lessons from the National Estuary Program
