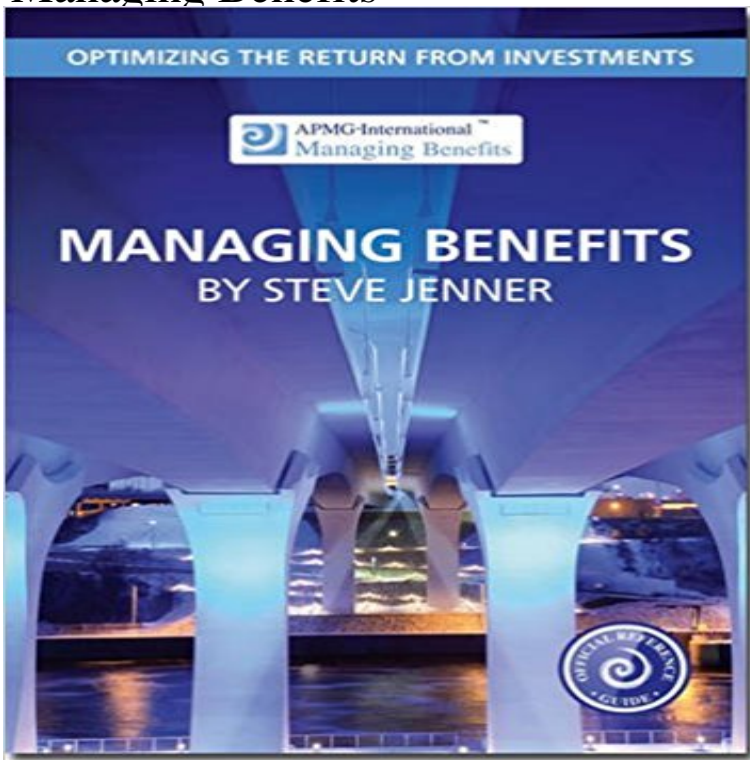


# Managing Benefits
