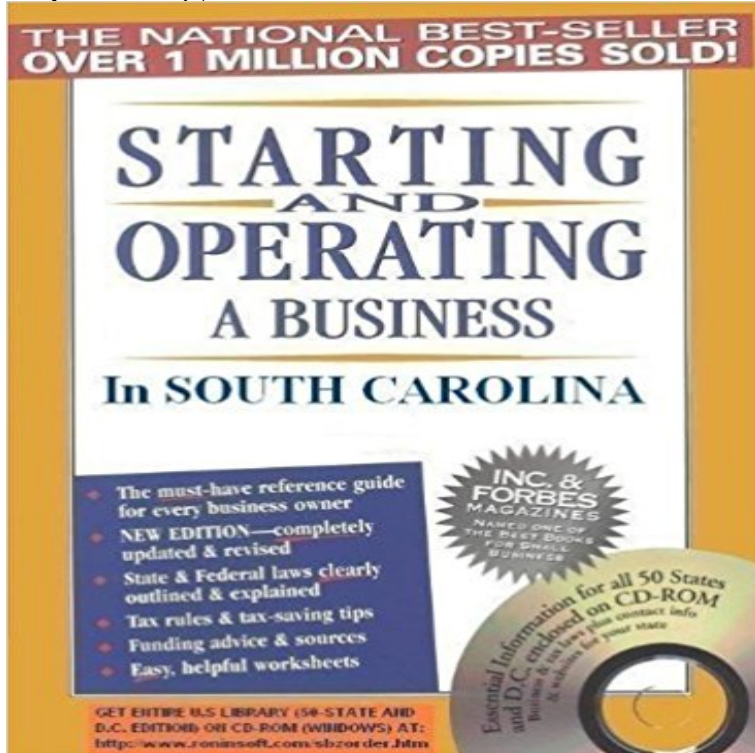


Starting and Operating a Business in South Carolina (Starting and Operating a Business in the U.S. Book 2015)

FEDERAL LAWS AND TAXES Federal tax and legal coverage includes individual income, self-employment, estate, gift, and excise taxes, federal payroll taxes, withholding of various taxes; securities laws and regulations; the Americans with Disabilities Act; environmental laws; minimum wage/overtime and child labor laws; anti-discrimination and HealthCare Reform laws that apply to employers; immigration laws affecting hiring; OSHA job safety and health requirements; ERISA (employee benefits) compliance; the Family and Medical Leave Act rules; mail order sales and telemarketing regulations; Internet taxation and

regulation; and much more.

SOUTH CAROLINA LAWS AND TAXES South Carolina tax and legal coverage includes the South Carolina state income tax, state corporate income and franchise taxes, South Carolina sales and use, property, and unemployment taxes, withholding of employment taxes, and other state and local business taxes; state fair employment laws; the South Carolina child labor laws; mandatory workers compensation insurance and new hires reporting by employers; wage payment requirements; when/if registration of fictitious business names (trade names) is required; state restrictions on hiring illegal aliens; other state labor laws; and much more.

OTHER IMPORTANT INFORMATION AND ADVICE In addition to extensive, up-to-date coverage of federal and South Carolina business laws and taxes, you will also find this e-book to be a gold mine of other useful information and advice for running your business. It covers topics such as an entire chapter on site selection for your business; obtaining financing and choosing accounting methods; dos and donts when buying an existing business, acquiring a franchise, or signing a lease; pros and cons of corporations, LLCs, and other business entities, as well as South Carolina filing fees and taxes for each type of entity.
