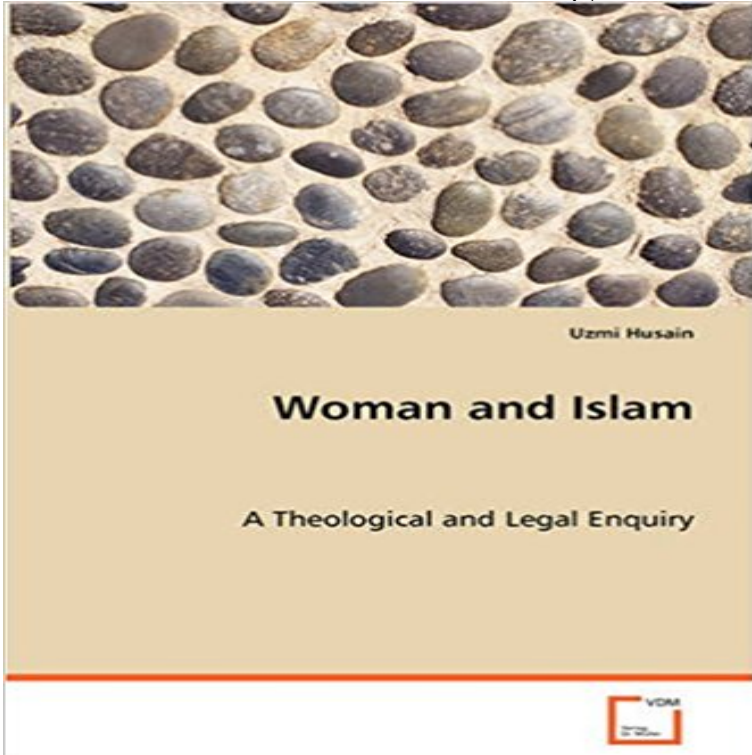


# Woman and Islam: A Theological and Legal Enquiry
